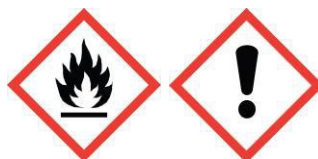

4. First aid measures

4.1. Description of first aid measures

General

Move victim to fresh air.
